

## **Photo, video and sound recordings at the event**

It is pointed out that photos, videos and sound recordings will be made at the event, which will be used by RP Media & Event OG ("Rising Productions") Event OG ("Rising Productions") - if necessary after processing - for an unlimited time and place, in particular for the purpose of reporting, documentation, information about the event, but also for advertising purposes of the organizer and "Rising Productions" and will be reproduced, distributed, broadcast or made available to the public on their websites, in social media (Instagram, Facebook, YouTube, TikTok, WhatsApp and similar), in the livestream of the event and, if necessary, in print media. The images may be reproduced, distributed, broadcast or made available to the public, whereby the persons concerned will not receive any remuneration for this and waive the assertion of any claims, in particular from the right to their own image and to claims for use.

The recordings will not be sold or passed on to third parties who pursue their own interests in the data - apart from the athletes themselves, if they are interested in acquiring permission to use the recordings. Excluded from this is the transfer to the event organizer, on whose behalf "Rising Productions" acts as a multimedia agency at the event, and in some cases social media services, which are regularly granted exploitation rights to the published data. The recordings are also passed on to processors if this is necessary to process the data.

"Rising Productions" ensures that no legitimate interests of persons depicted are violated. If, in individual cases, legitimate interests have been impaired, further processing will be discontinued immediately after becoming aware of this and the data will be deleted or the person concerned will be made unrecognizable, insofar as digital content is concerned. Naturally, it is not possible to make the data unrecognizable in print media that have already been issued.

The data is processed on the basis of the voluntary consent of the data subjects in accordance with Art. 6 para. 1 lit. a GDPR, the necessity for the performance of contracts with the data subjects in accordance with Art. 6 para. 1 lit. b GDPR, insofar as they are interested in acquiring permission to use the recordings, as well as on the basis of the legitimate interest of the event organizer and RP Media & Event OG, which is commissioned to carry out the event in the media, to promote the event and subsequent events and to raise their profile and that of the athletes and "Rising Productions" in accordance with Art. 6 para. 1 lit. f GDPR. Event OG in accordance with Art. 6 para. 1 lit. f GDPR to advertise the event and subsequent events and to raise awareness of the event, the sport, the athletes and "Rising Productions".
